

Livin' It Up Savvy Saving Competition Rules

Prizes

3 x monthly R2 000 cash prizes (that will only be deposited into a Capitec account held by each lucky draw winner).

How to enter

1. Download the Capitec Livin' It Up mobile game from your app store (existing players to update to the latest version of the game)
2. Play Livin' It Up until you unlock the character Nandi
3. Use the camera to take a screenshot of her house
4. Share the screenshot on Twitter with the official hashtag **#HelloSavvySaving** and tag **@CapitecBankSA** to enter (one post will count as a valid entry)
