How to enter

1. Use our app or dial *120*3279# to buy a Famous Brands voucher valued at R100 or more
2. The voucher must be from one of the following participating retailers: Steers, Wimpy, Debonairs Pizza, Mugg & Bean or Fishaways

Competition terms and conditions

By entering the competition, you agree to the following terms and conditions:

2. The organiser of the competition is Famous Brands South Africa, registration number 2001/004345/07 and/or its agencies, in conjunction with Capitec Bank Limited, registration number 1980/003695/06 (referred to as "the Organisers")

 - 4.1 Who are a Capitec client, with a valid and active Capitec Bank account that is in good standing

 - 4.3 Who are a citizen of and/or legal resident and currently residing in the Republic of South Africa (RSA)

7. Winners will be notified by SMS on 15 March 2023
