Capitec Bank Holdings Limited formally transitioned to IFRS 9 on 1 March 2018. The IFRS 9 Transitional Report was presented based on the group's 28 February 2018 financial information to illustrate the impact of implementing IFRS 9 on 1 March 2018. (¹) As set out in the Basel Committee on Banking Supervision's publication on the regulatory treatment of accounting provisions, the standard requires banks to publicly disclose whether they are applying a transitional arrangement for the impact of expected credit loss accounting on regulatory capital. Template KM1 provides users with information on the impact on the bank's regulatory capital and leverage ratio compared to the bank's "fully loaded" capital and leverage ratio had the transitional arrangement not been applied. Capitec Bank Holdings Limited applies the transitional arrangement for the impact of expected credit loss accounting on regulatory capital as referred to in Directive 5 of 2017 and in the BCBS's publication on the regulatory treatment of accounting provisions. Per Directive 5 of 2017, the Office of the Registrar of Banks deemed it appropriate to introduce a transitional arrangement in order to avoid an immediate capital shock and to allow banks to rebuild capital resources following the initial negative impact arising from the introduction of IFRS 9. The IFRS 9 transitional amount (adjustment amount) and the increase in deferred tax asset as a result of the implementation of IFRS 9 is implemented on 1 March 2018, and the impact of fully loaded ECL accounting model disclosures above have been reported from the first quarterly reporting date after implementation of IFRS 9, which is May 2018 Q1.

(²) As Capitec has a net cash inflow after applying the run-off factors, outflows for the purpose of the ratio are deemed to be 25% of gross outflows.

(³) On terms of Banks Act regulations, banks may not disclose their D-SIB requirement.
